

# **UNFPA Special Initiative on Census**

UNFPA's Special Initiative on Census seeks to ensure that no country fails to carry out a Population and Housing Census during the 2010 census round (2006-2015) either due to financial constraints or lack of technical capacity. Supporting countries in the collection, analysis and dissemination of data for development is a critical component of UNFPA's mandate

The Special Initiative facilitates access to technical resources and training opportunities in preparation for the census and encourages South-South cooperation across countries and regions.

It also seeks to ensure that data generated from the census are widely disseminated and extensively used for the preparation of development plans and programmes, as well as for their monitoring and evaluation.



# **Myanmar 2014 Census**

A population census is the total process of collecting, compiling, evaluating and analyzing as well as publishing and disseminating demographic, economic and social data pertaining, at a specific time, to all the persons in a country.

The planning and management stage of the Myanmar 2014 census has already started; it is expected that the process will be finalized by the end of 2016. The census enumeration will take place during the period 30 March to 10 April 2014. Provisional results are expected to be ready by July 2014 and the definitive results released in early 2015.

### Benefits

No census has been undertaken in Myanmar since 1983. Without up-to-date data, it is difficult for planners, policy makers and programme managers to formulate, implement, monitor and evaluate development programmes in the country. The census will enhance Myanmar's contribution to:

- (a) Poverty reduction by helping to identify groups needing spe cial attention
- (b) The empowerment of local communities through enhanced access to local social and demographic data
- (c) Increased participation in local decision-making by increasing the knowledge of local needs and demographic trends.

# Challenges

The success of a census will depend on a number of factors including national commitment, donor commitment, capacity building and quality assurance. There are, however, a number of challenges and potential risks that need to be taken into account as the census is implemented. These include the need to:

- (a) Mobilize adequate financial resources in a timely manner
- (b) Continue to strengthen technical capacity in census-taking
- (c) Facilitate access of enumerators to conflict and hard to reach areas
- (d) Ensure the support and cooperation of various ethnic groups for the census

The Government is aware of all these challenges and risk-mitigation measures have been identified to address them.

### Costs

The total cost of the 2014 Population and Housing Census is estimated at US\$58.5 million.

UNFPA's has planned to contribute US\$5 million to the 2014 Census while the Government has committed US\$15 million. This leaves a funding gap of US\$38.5 million.



# **UNFPA's Support**

In keeping with the goal of the UNFPA Special Initiative on Census, UNFPA is currently providing technical assistance on census preparation activities including the recruitment of a Chief Technical Advisor for Census and the dispatch of short-term technical advisors to each of the areas of census operation such as mapping and cartography, questionnaire design, data capturing and processing, advocacy and publicity as well as data analysis. Currently, UNFPA is providing training to government agencies on data collection. Additionally, UNFPA will support the conduct of the pilot census scheduled to take place in 2013 in 20 townships to allow for the testing of census-related tools including the census questionnaire.

UNFPA facilitates the sharing of experiences, the transfer of knowledge and expertise and the development of robust monitoring, evaluation and quality control systems to ensure reliability of the census. UNFPA has formed an International Technical Advisory Board consisting of prominent experts to advise the Government throughout the census operation.
